The successful candidate is able to develop system and program-level analysis reports and briefings for federal client management and senior executive personnel, and ensures required cyber security policies are adhered to and that required controls are implemented. This position requires a knowledge of network technologies such as Windows and Linux operating systems; database security; active directory; service oriented architectures; security architectures; and incident management. The position requires some domestic travel and an ability to work with clients resident in multiple timezones.
